THIS DECLARATION OF TRUST is made on this the 18th day of MARCH, 1991,

BY:

1. Mr. L. BASAVALINGAPPA, son of Linge Gowda, aged about 55 years, residing at No.336, 12th Main Road, Banashankari I Stage, Bangalore-50;
2. Mr. B.S. BYRAIAH, son of late Lingaiah, aged about 42 years, residing in S.No.32, 'Santosh Sadan', Srikantapura, Bangalore-Tumkur Road, Bangalore-73;
3. Mrs. B. BHAGYA, wife of Mr. B.S. Byraiah, aged about 30 years, residing in S.No.32, 'Santosh Sadan', Srikantapura, Bangalore-Tumkur Road, BANGALORE-73.

hereinafter jointly called as 'the Trustees'.

WHEREAS, it is the desire of the Trustees to declare Rupees One Thousand five hundred only (hereinafter called as "the said sum") on irrevocable trust to establish educational institution for educational purposes.

NOW, THEREFORE, THIS DEED WITNESSETH AS FOLLOWS:

1. That with a view to effectuating the said desire, the Trustees do hereby declare that they have made over and transferred the said sum of Rupees One Thousand and five hundred only on irrevocable trust to be used for "EDUCATIONAL PURPOSES" and, as more particularly specified hereinafter in accordance with the terms of this deed, subject to the powers, conditions and provisions hereinafter appearing.

2. The Trustees do hereby declare that they shall hold and stand possessed the said sum, together with such additions and accretions thereto, as may be made by donations, profits, gains and incomes and otherwise (the whole

3. The Trust will be known as "**NEHRU SMARAKA EDUCATION TRUST**" and its office shall be in S.No.32, Santosh Sadan, Srikantapura, Bangalore-Tumkur Road, Bangalore-560 073, and/or any other place/places the trustees may decide from time to time.

4. The Trustees shall hold the trust property for being applied to the following educational purposes and objects within India, for the benefit of the members of general public, without any distinction of caste, sect, creed, sex or religion:

- a) To impart, spread and promote in literature, Arts, Science, Social Science, Technology, Engineering, Medicine, Commerce.
- b) For the furtherance of the above object:
 - i) To found, maintain, organise, run, manage, supervise, superintend, co-ordinate, affiliate, control, guide, schools, colleges, universities, institutions.
 - ii) To arrange, hold, conduct and guide, seminars, workshops, conferences.
 - iii) To run hostels, boarding houses, maintain and develop museums, laboratories.
 - iv) To maintain libraries, lecture halls, practical classes and other educational activities and institutions.
 - v) To hold examinations and to grant certificates of proficiency or other academic distinctions or title to the persons who complied with the conditions laid down in the regulations and bye-laws of the Trust.

- vi) To grant stipends scholarships, studentships, and other allowance, facilities, interest free loans, concessions and gratuities to the deserving students and candidates.
- vii) To provide facilities for giving residential accommodation and boarding house for teachers, staff and any other person engaged in carrying in any of the objects of the Trust.
- c) Generally, such other objects of "educational purposes" and incidental or ancillary thereto.

5. a) The profits, incomes and trust properties shall be applied in India and solely for the promotion of the aforesaid objects of the trust and no part or portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise, howsoever, to trustees or any person.

b) It is hereby expressly declared that no part of the profits, incomes and trust properties shall be applied for any purpose which is not educational purpose and nothing contained herein shall be construed to authorise the trustees to utilise the trust property for any non-educational purpose.

6. (a) A trustee shall hold his/her office for life. His/her office shall be vacated if - (i) He/she tenders resignation from such office in writing ii) he/she found to be of unsound mind iii) he/she is asked in writing to resign unanimously by the remaining trustees.

Provided, however, the aforesaid clause 6(a)(iii) shall not apply in the case of trustee viz. Smt. B. Bhagya.

b) The appointment, inclusion or co-option of trustees either to fill vacancy or as additional trustees shall be by resolution of the trustees for the time being.

7. a) The Trustees themselves constitute the Managing Committee for managing the affairs of the Trust. The General Management and control shall vest with the Managing Committee. Mr. L. Basavalingappa and Mrs. B. Bhagya, the trustees herein, shall be the "Founder President" and "Founder Secretary" respectively, who shall hold their respective office as such for life or until they resign on their own. So, however, nothing prevents them from continuing as trustees.

b) the Managing Committee shall be empowered to make all appointments of staff/employee, and remove, suspend, dismiss the said staff/employee; to purchase land, building or to sell or lease the trust property; to raise loans from Nationalised or Schedule Bank/s and to have overdraft facility etc; to invest the amount in debenture, fixed deposits, National Savings Certificates etc., in the interest of the trust and generally, to do anything for carrying out the objects of the Trust.

c) The Managing Committee shall ordinarily meet during the 1st week of every month to review the working of the trust and to transact any other business of the trust.

d) Subject to the general control and supervision of the Managing Committee, the president and the Secretary shall manage the trust and its properties and funds and carry on the day-today affairs of the trust.

8. The Trustees shall open Bank Account/s in the name of the trust and the same shall be operated by the 'Secretary'.

9. The funds of the trust shall be invested, in the modes specified under the provisions of Sec.13(1)9d) read with Sec.11(5) of the Income-tax Act, 1961, as amended from time to time.

10. There shall be maintained regular accounts of receipts and expenditure of the Trust. Subject to the provisions of Section 12A(b) of the Income-tax Act 1961, the accounts shall be audited. The accounts shall be closed on 31st March, each year.

11. It shall be lawful for the trustees from time to time to frame such Rules and regulations for the management and administration of the trust as they shall think fit and to alter or vary the same from time to time and to make new rules and regulations; provided that such rules shall not be inconsistent with the terms and intents of these presents.

12. the trustees viz. Mr. L. Basavalingappa and Mrs. Bhagya may nominate the nominees on their behalf.

13. In the event of dissolution or windingup of the trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among trustees, but the same shall be transferred to another charitable trust whose objects are similar to those of this trust and which enjoys recognition U/s. 80G of the Income-tax Act, 1961, as amended from time to time.

14. the trust hereby formed shall be irrevocable.


